The following policies are included in this agreement:

- **A credit card is required to hold a party reservation.**
- **PLEASE NOTE: A 25% deposit will be made to this credit card for the reservation. Charges for no-shows, under 7 days cancellations, applicable gratuities and facilities fees will be made to this card the day of the party ONLY if they be applicable.**
- **Nails of America - Bridgeland has a 7 days cancellation policy. Any services booked and cancelled with less than 7 days notice (including no-shows) will be charged to the credit card in this agreement at the price of the service(s) booked plus a 20% gratuity charge.**
- **Once your party is confirmed as booked and during the party, we are unable to accommodate changes to the services scheduled or include add-on services in order to stay on schedule for your party patrons. (Add-on services include: French polish, Paraffin, nail art, nail repair, Gelish, etc).**

- **We offer a large assortment of OPI, CND, Kiara Sky polish, a limited selection of CindiNaturals Organic polish and over 100 colors of Gelish, soak-off polish.**
- **Guests must arrive at least 15 minutes prior to their scheduled appointments to allow for check-in and choosing polish colors. Services are scheduled back-to-back, so in order to stay on schedule, we may need to modify services for guests who arrive late.**
- **Pre-prepared or catered foods may be brought into the salon for a \$25-50 Facility fee.**
- **In accordance with liquor license regulations, NO OUTSIDE ALCOHOL OR BEVERAGES ARE ALLOWED INSIDE THE SALON.**
- **In accordance with liquor license regulations, ALCOHOL MAY NOT BE CARRIED OUTSIDE THE SALON.**
- **Check in time is 15 minutes prior to start of appointments. If unexpected complications lead to late arrival, your services will still need to end at their scheduled time. Please allow adequate time to arrive at Nails of America Bridgeland so that your day can be experienced to its fullest.**
